

Privacy Policy

This privacy policy has been compiled to better serve those who are concerned with how their personal information is being used online. Personal information can be used to identify, contact, or locate a single person, or to identify an individual in context. Please read our privacy policy carefully to get a clear understanding of how we collect, use, protect or otherwise handle your Personally Identifiable Information in accordance with our website and newsletter signups. We may update this privacy policy from time to time in order to reflect, for example, changes to our practices or for other operational, legal or regulatory reasons, so we recommend reviewing it occasionally.

What personal information do we collect from users that visit our website?

When you visit the website, we automatically collect certain information about the way you browse our website and your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device.

We also automatically collect information about how you browse the website, which pages you visit and generally how you interact with our website. Additionally, as you browse the website, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the website, and information about how you interact with our website. We refer to this automatically-collected information as “Device Information.”

When do we collect information?

We collect information from you when you browse our website, subscribe to a newsletter, fill out a form, use Live Chat or enter information on the forms of our website. We refer to this information as “Enquiry Information”.

We collect enquiry information from you such as your name, email address, phone number, website and country of origin.

We also use cookies to help us compile aggregate data about website traffic and website interaction so that we can offer better website experiences and tools in the future.

We also use trusted third-party services that track this information on our behalf (Hubspot and Google Analytics).

Turning off cookies

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You can do this through your browser settings. Since browser is a little different, look at your browser's Help Menu to learn the correct way to modify your cookies.

We track website on Google Analytics (through cookies described above), however if you visit our page for the first time, you can accept or ignore cookies to run on the site via the pop up enabled on our website. If you turn cookies off, it will not affect the user's experience.

How do we protect your information?

Our website is scanned on a regular basis for security holes and known vulnerabilities in order to make your visit to our website as safe as possible.

We use regular Malware Scanning

Your personal information is contained behind secured networks and is only accessible by a limited number of persons who have special access rights to such systems, and are required to keep the information confidential.

We implement a variety of security measures when a user enters, submits, or accesses their information to maintain the safety of your personal information.

Third-party disclosure & Information Sharing

As a business to business provider, we will often share your data an affiliate distributor in order to fulfil customer requests, such as to purchasing products. This is the only instance where we will share customer data.
